IMPORTANT REMINDERS

- There will be no drinking of alcoholic beverages on pool property.
- Smoking is prohibited on pool property, including the parking lot. Vapor and smokeless tobacco are also prohibited.
- Pool passes are to be used only by those persons listed above. Passes loaned to other persons will be revoked.
- The babysitter pass may only be used when the person is watching the child in place of the parent. Proper pool attire must be worn.
- Acceptable language must be used at all times.
- The pool management has the right and responsibility to have persons removed from the pool who do not abide by the rules.
- Parents are expected to reviews the pool rules that are posted throughout the pool area with their children.
- No glass containers are permitted on pool property.
- All guidelines set for by the PA Dept. of Health and CDC will be followed by all pool patrons, including social distancing, frequent hand washing/sanitation, etc.
- Outside food/drink is not permitted
- Proper swimming attire must be worn in order to enter the pool. Street Clothing is not permitted inside the pool.
- Public Displays of Affection (PDA) are not permitted on pool grounds. Repeat offenders will be asked to leave.
